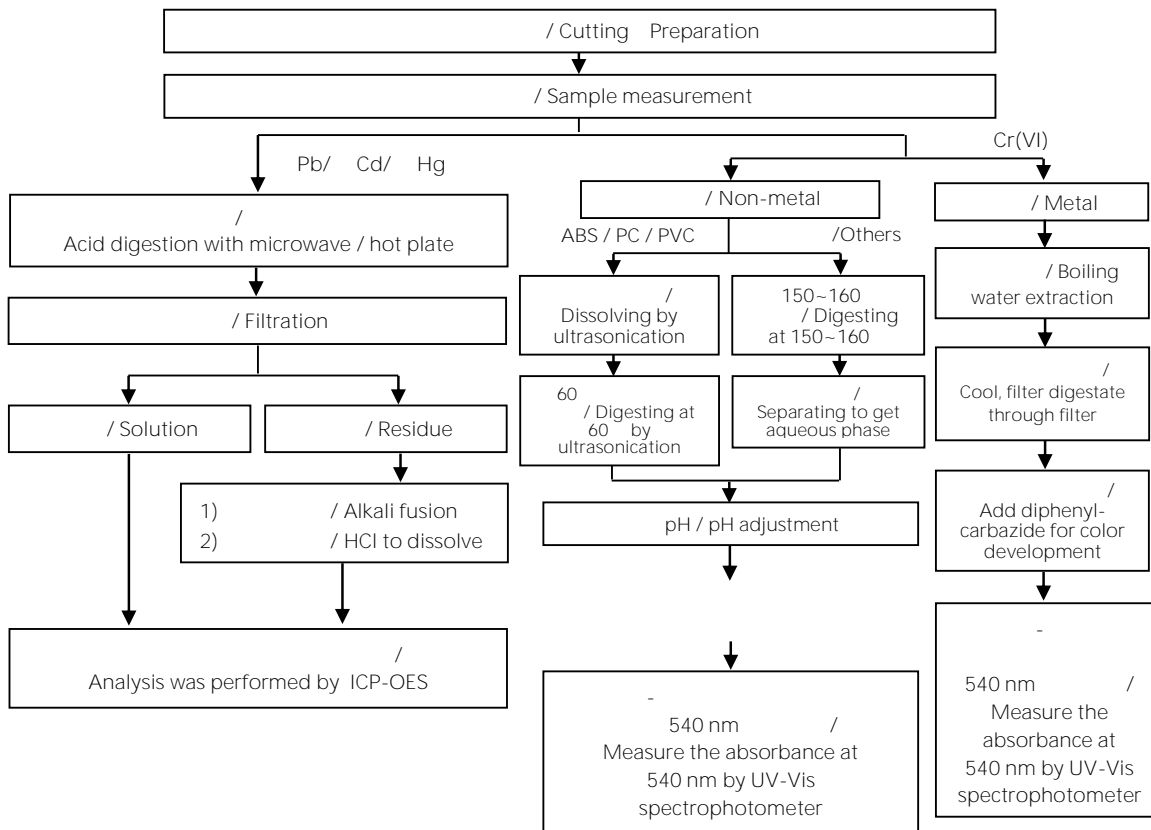

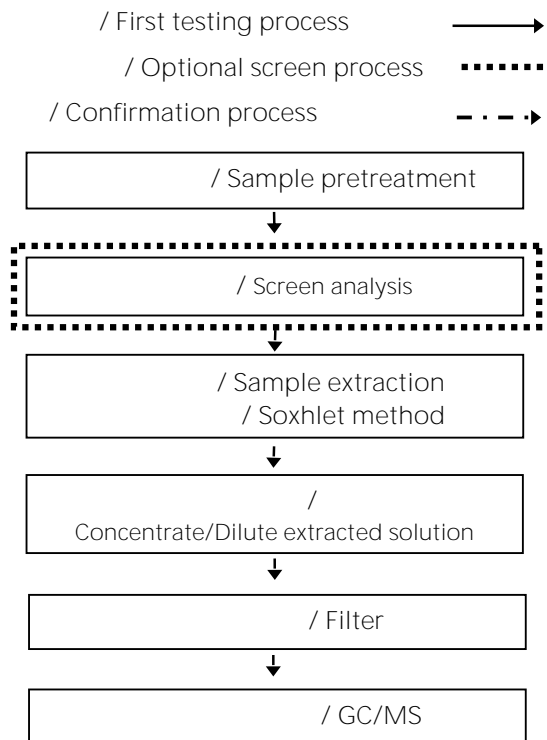

/ Analytical flow chart - PBBs/PBDEs



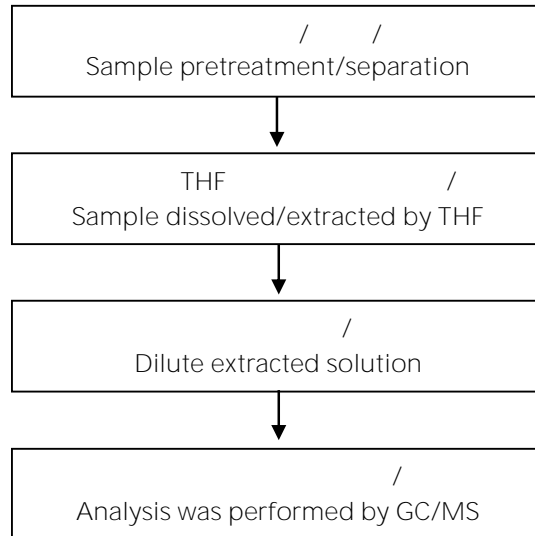

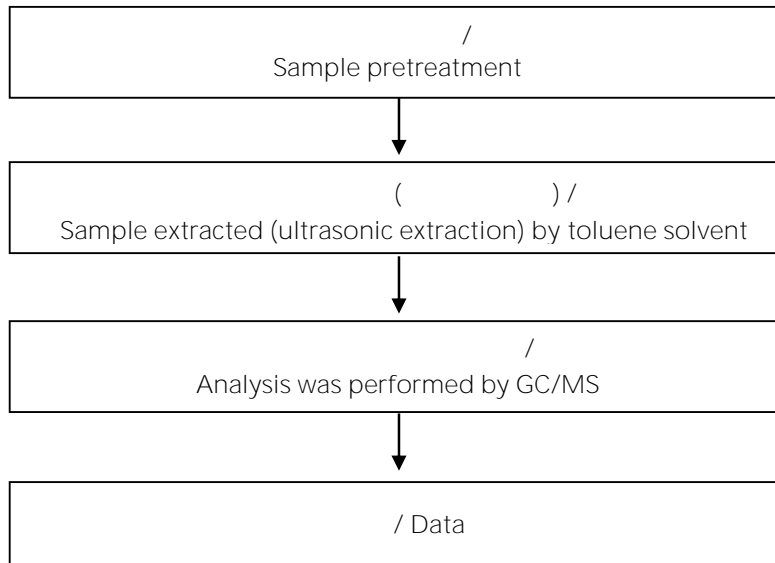
